



BYLAW NO. 119

A BYLAW TO ADOPT A TICKET INFORMATION SYSTEM FOR BYLAW OFFENCES

WHEREAS the Regional District may, pursuant to section 266 of the *Local Government Act*, establish a system of fines and penalties for the purpose of enforcing its bylaws including laying an information by means of a ticket;

AND WHEREAS the Regional District may, in a ticket information bylaw, describe an offence against a bylaw using words or expressions it deems appropriate and designate persons to act as bylaw enforcement officers;

AND WHEREAS the Regional Board deems it expedient to authorize the use of a ticket information system for the enforcement of certain bylaws;

NOW THEREFORE the Board of Directors of the Strathcona Regional District, in open meeting assembled, enacts as follows:

Definitions

1. In this bylaw, unless the context otherwise requires;

“animal control officer” means a person designated by the Society for the Prevention of Cruelty to Animals to enforce the animal control provisions of local government bylaws;

“bylaw compliance officer” means a person appointed by resolution of the Board of the Regional District to enforce one or more of its bylaws;

“bylaw enforcement officer” means a person or class of persons designated in this bylaw as having authority to enforce a bylaw or bylaws of the Regional District by means of a ticket information;

“continuing offence” means an offence that is repeated or continued by a person after a ticket information has been laid with the person;

“peace officer” means a member of the Royal Canadian Mounted Police.

Application

- 2. The bylaws listed in Column A of Schedule 1, attached to and forming part of this bylaw, are hereby designated as bylaws to be enforced by the laying of a ticket information for contravention of the bylaw provision or provisions identified in this bylaw.

Enforcement Personnel Designated

- 3. The persons listed in Column B of Schedule 1 are hereby designated as bylaw enforcement officers for the purpose of enforcing the bylaws listed in Column A opposite the person's title or job position.

Offences Described

- 4. The words, expressions and general descriptions set forth in Column A of Schedules 2 to 16, attached to and forming part of this bylaw, are hereby authorized to designate the offence alleged to have been made against the bylaw provision listed in Column B opposite the relevant words, expressions and descriptions.

Penalties for Ticket Offences

- 5. The fines set forth in Column C of Schedules 2 to 16 are hereby established as the penalties in relation to the offences identified in Column A opposite the fine amount.

Continuing Offences

- 6. In the case of a continuing offence the designated enforcement officer may, acting reasonably, issue a separate ticket for each offence but the aggregated fine amount for a continuing offence may not exceed \$1,000 (One Thousand Dollars) in a single day.

Repeal

- 7. Regional District Ticket Information System Bylaw No. 2794 is repealed in its entirety.

Citation

- 8. This bylaw may be cited for all purposes as Bylaw No. 119, being Bylaw Contravention Ticket Information System Bylaw 2012.


