- 1) This bylaw may be cited as the "Campbell River Area Zoning Bylaw, 1991, Amendment No. 48."

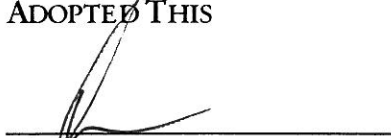
