The board of the Strathcona Regional District in open meeting assembled, enacts the following amendments to the "QUADRA ISLAND ZONING BYLAW, 1990," BEING BYLAW No. 1213:

- 1) This bylaw may be cited as the "QUADRA ISLAND ZONING BYLAW, 1990, AMENDMENT No. 94."





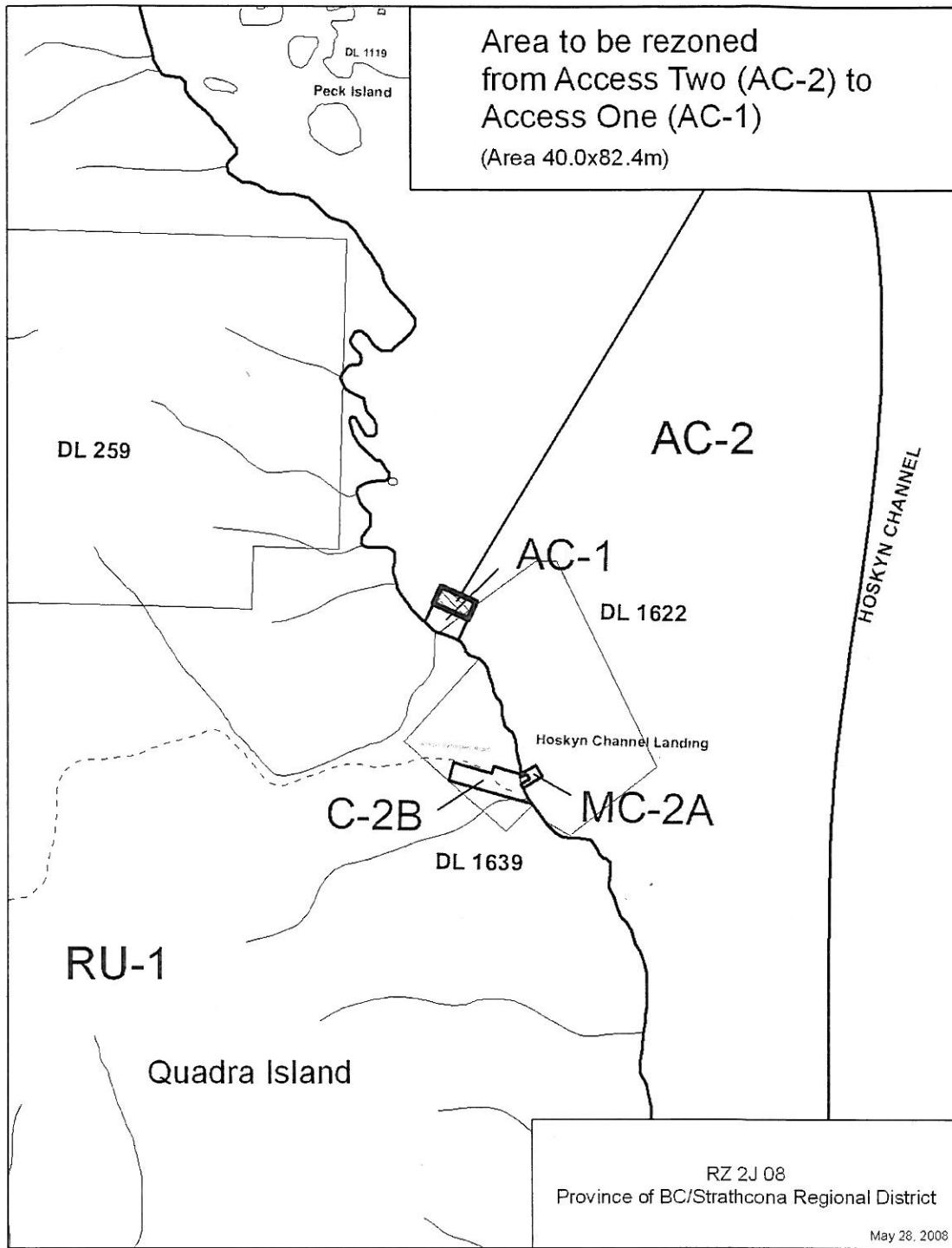
## SCHEDULE 'A'

### **SECTION ONE    ZONING AMENDMENT**

That area legally described as That Part of District Lot 1622, Together with Unsurveyed Crown Foreshore or Land Covered by Water being Part of the Bed of Hoskyn Channel, All within Sayward District (ILMB File No. 1409803), Quadra Island is rezoned from 'Access Two (AC-2)' to 'Access One (AC-1).'

### **SECTION TWO    MAP AMENDMENT**

Schedule "A-10" of Bylaw No. 1213, being the "Quadra Island Zoning Bylaw, 1990" is amended by rezoning area legally described as That Part of District Lot 1622, Together with Unsurveyed Crown Foreshore or Land Covered by Water being Part of the Bed of Hoskyn Channel, All within Sayward District (ILMB File No. 1409803), Quadra Island from 'Access Two (AC-2)' to 'Access One (AC-1)', as shown on attached "Appendix 1."
