A bylaw to repeal "Fireworks Regulation Extended Service Conversion Bylaw No. 2002, 1997" and all amendments made thereto.

WHEREAS the board of the Comox-Strathcona Regional District adopted Bylaw No. 2002 being "Fireworks Regulation Extended Service Conversion Bylaw No. 2002, 1997" on the 25th day of May, 1998;

AND WHEREAS the Strathcona Regional District has determined that this service is no longer required in Electoral Area "A";

AND WHEREAS the board of the Strathcona Regional District wishes to repeal "Fireworks Regulation Extended Service Conversion Bylaw No. 2002, 1997" and all amendments made thereto in accordance with section 802 [*Amendment or repeal of establishing bylaws*] of the *Local Government Act*;

NOW THEREFORE the board of the Strathcona Regional District in open meeting assembled enacts as follows:

REPEAL

1. Effective December 31st, 2009, Bylaw No. 2002 being "Fireworks Regulation Extended Service Conversion Bylaw No. 2002, 1997" and all amendments made thereto are hereby repealed.




