



## BYLAW NO. 188

---

### A BYLAW TO AMEND THE STREET LIGHTING SERVICE PROVIDED WITHIN ELECTORAL AREA C (DISCOVERY ISLANDS-MAINLAND INLETS)

---

**WHEREAS** the former Comox-Strathcona Regional District has, by Bylaw No. 2539, established the service of street lighting within Electoral Area C (Discovery Islands-Mainland Inlets);

**AND WHEREAS** the Comox-Strathcona Regional District was divided into the Comox Valley Regional District and the Strathcona Regional District by letters patent effective February 15, 2008;

**AND WHEREAS** a service of the former Comox Strathcona Regional District that is provided within all or part of the area comprising the Strathcona Regional District remains in force as a service of the Strathcona Regional District until amended or repealed;

**AND WHEREAS** the Strathcona Regional District wishes to amend the street lighting service provided within Electoral Area C;

**AND WHEREAS** the consent of at least 2/3 of the participants of the existing street lighting service has been obtained in accordance with s.802 of the *Local Government Act*;

**NOW THEREFORE** the Board of Directors of the Strathcona Regional District, in open meeting assembled, enacts as follows:

#### **Amendments**

1. Bylaw No. 2539, being Electoral Area 'J' Streetlighting Service Establishment Bylaw No. 2539, 2003, adopted by the Comox-Strathcona Regional District on March 31, 2003 is hereby amended as follows:
  - (a) by deleting the words "*Electoral Area 'J'*" in sections 1, 2 and 3 and substituting therefor the words "*Electoral Area C*";
  - (b) by deleting the words "*parcel taxes*" in section 4 and substituting therefor the words "*property value taxes*";
  - (c) by deleting sections 5.1 and 5.2 and substituting the following new section:

#### ***Maximum Requisition***

5. *The maximum amount that may be requisitioned annually for the service is \$7,880.00.*

(d) by deleting section 7 and substituting the following:

***Citation***

7. *This bylaw may be cited for all purposes as Bylaw No. 2539, being Electoral Area C Streetlighting Service Establishment Bylaw 2003.*

2. This bylaw may be cited for all purposes as Bylaw No. 188, being Electoral Area C Streetlighting Service 2003, Amendment No. 1.


