



BYLAW NO. 137

A BYLAW TO AMEND BYLAW NO. 1352, BEING RECREATION COMPLEX COMMISSION BYLAW, 1991

WHEREAS the former Comox-Strathcona Regional District has, by Bylaw No. 1352, established a commission for the Strathcona Gardens Arena and Swimming Pool;

AND WHEREAS a bylaw of the former Comox-Strathcona Regional District that applies within all or part of the area comprising the Strathcona Regional District remains in force as a bylaw of the Strathcona Regional District until amended or repealed;

AND WHEREAS the Strathcona Regional District wishes to amend the provisions of the aforesaid Bylaw No. 1352;

NOW THEREFORE the Board of Directors of the Strathcona Regional District, in open meeting assembled, enacts as follows:

Amendments

1. (1) Bylaw No. 1352 is amended by deleting section 2 in its entirety and substituting therefor a new section 2 as follows:

2. *The Commission shall comprise 5 members appointed as follows:*
 - (a) *2 councillors of the City of Campbell River appointed by the Regional Board on the written recommendation of the City of Campbell River,*
 - (b) *1 director for the City of Campbell River appointed by the Regional Board,*
 - (c) *the director for Electoral Area D (Oyster Bay-Buttle Lake), and*
 - (d) *1 person appointed by the Regional Board to represent the community at large.*

- (2) A new section 2A is added, as follows:

- 2A. (1) *Subject to the provisions of subsection (2) the Regional District may appoint alternate members to take the place of, vote and generally act in all matters for each absent member provided that each alternate member shall have the same qualifications as the member they are appointed to take the place of.*
 - (2) *The alternate directors for the members who are directors on the Regional Board are deemed to be the alternate members for those members of the Commission.*

- (3) A new section 2B is added, as follows:

- 2B. (1) *Subject to the provisions of subsection (3) the term of office for each member of the Commission shall commence at the time of their appointment and shall end when their term of office as director or councillor ends, whichever the case may be.*

(2) For clarity, the term of office for a person appointed as an alternate member shall end when the term of office for the member they represent has ended.

(3) Members and alternate members of the Commission, except the member appointed pursuant to section 2(c), shall serve at the pleasure of the Regional Board and any member or alternate member appointed to replace them shall have the same qualifications as the member or alternate member that they are appointed to replace.

(4) Section 11 is deleted in its entirety and a new section 11 is substituted therefor as follows:

11. This bylaw may be cited for all purposes as "Bylaw No. 1352, being Strathcona Gardens Commission Establishment Bylaw 1991".

Transitional Provisions

2. A person who has been appointed and currently sits as a member of the Commission in accordance with a bylaw, rule or process which was in effect prior to the coming into force of this bylaw shall continue to serve in such capacity until their term has expired or they are replaced in accordance with this bylaw, whichever first occurs.

Effective Date

3. This bylaw shall come into effect immediately upon adoption.

Citation

4. This bylaw may be cited for all purpose as "Bylaw No, 137, being Recreation Complex Commission Bylaw 1991, Amendment No. 1."

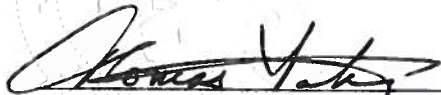
